## AUSTRALIA NEW ZEALAND CROSS ECONOMIC TRADE AGREEMENT

The AUSTRALIA NEW ZEALAND CROSS ECONOMIC TRADE AGREEMENT (known as ANZCERTA or The CER Agreement) The agreement entered into force on 1 Jan 1983. Since 1 Jul 1990, all goods meeting ANZCERTA rules of origin criteria can be traded across the Tasman free of duty and quarantine import restrictions.

## COMPREHENSIVE AND PROGRESSIVE AGREEMENT FOR TRANS-PACIFIC PARTNERSHIP

The Comprehensive and Progressive Agreement for Trans-Pacific Partnership (CPTPP) entered into force on 30 December 2018.
