## PERU-AUSTRALIA FREE TRADE AGREEMENT

The agreement establishing the PERU-AUSTRALIA FREE TRADE AGREEMENT (PAFTA) came into force on 11th February 2020.

The quota volume will gradually increase each year, 2020:7,000t, 2021:7,300t, 2022:7,600t, 2023:8,000t, 2024:8,300t, 2025:8,700t, 2026:9,000t, 2027:9,300t, 2028:9,700t, 2029 onwards:10,000t
