F. Recommended withholding period for CALF MEAT drinking milk from cows on intramammary Lactating Cow treatment

Milk from cows treated with Lactating Cow antibiotic should NOT be fed to bobby calves until after the milk withholding period (table D).

If calves do drink treated milk within the withholding period, the withholding period for the calf meat is the same as the withholding period for cow meat (table E) starting from the last feed of treated milk.
